All Sign Submittals Require The Following:

- The application shall be accompanied by the written consent of the owner or lessee of the premises upon which the sign is to be erected.
- Signs requiring plan approval shall submit construction documents with site plan, dimensions, materials and details of construction showing conformance to the Ohio Building Code.

Ground Signs:

Plan approval is required for signs over 6’ in height from existing ground level or any sign that has electric regardless of height.

Fees:

If the product exceeds 6’ in height*:	Non-Lighted Sign	\$ 75.00
	Lighted Sign (existing electric)	\$150.00
	Lighted Sign (new service)	\$300.00

*If the product exceeds 200 feet and/or the top of the sign exceed 10’-0” above finished grade, the sign will require submittal of three (3) sets of sealed drawings¹ for approval, along with the items listed above for all sign submittals.

Wall Signs:

Fees:

If the product is larger than 20 square feet.*	Non-Lighted Sign	\$ 75.00
If the product has electric regardless of size*	Lighted Sign	\$150.00

*If the square footage exceeds 50 square feet, the sign will require submittal of three (3) sets of sealed drawings¹ for approval, along with the items listed above for all sign submittals.

Multiple Wall Signs:

- Permits for multiple wall signs are required to conform to the following:
- a. Signs are to be at a single location for a single tenant/owner.
 - b. The total maximum fee for a group of three (3) signs or more will be twice the fee.

¹ Requires the seal of an Ohio Architect or an Ohio Professional Engineer
